2. If you FAIL TO ENTER A PLEA to the charge(s) BY THE APPEARANCE DATE SHOWN ON THE CITATION, an additional charge may be filed against you for Violate Promise To Appear, warrants issued for your arrest, and you may be denied renewal of your driver license.
3. If you wish to enter a plea of GUILTY OR NOLO CONTENDERE, please indicate in the proper space provided. Refer to the fine schedule to determine the total amount of fine(s) and cost acceptable to the Court. These fines apply only to cases handled prior to trial or judgment being entered. RETURN YOUR COPY OF THE CITATION & THIS LETTER WITH YOUR REMITTANCE, PAYABLE TO MILAM COUNTY, TO ASSURE PROPER CREDIT.
4. If you wish to enter a plea of NOT GUILTY, advise the court by checking #3 or #4 on this Plea Form on or before the appearance date. You will be notified by the court when to appear for trial.
5. You may be able to require that a charge be dismissed by successfully completing a Driving Safety Course/Motorcycle Operator Training Course. You will lose that right if you do not provide the Court with a written request to take the course on or before your appearance date. Only one charge may be dismissed. (See request form opposite side)

**REQUEST FOR DRIVING SAFETY COURSE/MOTORCYCLE OPERATOR COURSE**

*Under Article 45.0511 Code of Criminal Procedure a Certified Return Receipt is Required.*

1. Submit a copy of a valid Texas Driver's License or Permit.
2. Enter a plea of Nolo Contendere (No Contest) or Guilty (See opposite side for plea form.)
3. Provide proof of liability insurance.
4. Sign affidavit and have it **NOTARIZED**.
5. Send **CASHIERS CHECK OR MONEY ORDER** in the amount of **\$112.00 (No Personal Checks)**.
6. Driving Safety Course must be completed 90 days after plea/request received.
7. You are not eligible to take a driving safety course if you were traveling a rate of speed that is 25 mph or more over the posted speed limit or hold a CDL License.
8. You will receive a letter from us with further instructions.

**SWORN AFFIDAVIT**

I hereby swear or affirm that I have not taken a driving safety course in the twelve months preceeding this offense for ticket dismissal. I am not in the process of taking a driving safety course under Article 45.0511, Code of Criminal Procedure that is not yet reflected on my official DPS Driver Record.
