Public Participation about Solar:

Matt Goodson- provided a powerpoint (see attached)

Mr. Goodson- went through his powerpoint and stated that he lives in PCT #2, moved here 6 years ago. Concerns are that solar is going to be surrounding his property. One thing we have found is that Solar is one of the most heavily taxed subsidized industries in the nations. Most solar farms qualify for a ITC; investment Tax Credit, its about 26% of the construction cost of the project. So you already have a large amount of federal tax dollars going to the project. Most abatements go off a point system, going off the capital investment and jobs that will be created for the community, we show that most of these are going to be at 50%, a 2 year 50-60% that they qualify for. The 10 year seems a little long for me. My kids go to Cameron School District seems like they could really use that money. Job growth is another big concern, you are adversely affecting a lot of surrounding landowners and property values. When you look into the potential job loss through feed stores and fertilize salesmen. You take this land out of ag use and its going to be that way permanently. The environmental impact that will be on the land, will be very hard to get back into AG. Roads are a concern, CR273 and CR275; drainage off the roads into Pond Creek. Run-Off water is a scary thought. Cadmium is a problem if it runs off into our water. Troy ISD actually did not pass their tax abatements; I am sure there is a reason. Louisiana Farm Bureau is going to quit giving tax abatements for solar projects or the State of Louisiana is. They are seeing the loss of ag in acreage and seeing the negative effects of that.

Sherri Brantley- I have my property surrounded by one side and across from the front of my house. I back Matt 100% on everything he said. First of all, I would like to say in my opinion that Solar Farms are really Industrial Scales Solar Plants not farms, the word farms is used to lure people into a false sense of security. They say industrial scale solar plants shouldn't be put near residents in the city or residential areas so why should they be put near homes in the country. The run-

off is toxic from the panels which are made in China by the way. The run-off will go straight into our tank, that's where we fish and we eat those fish, when our tanks are full it goes into around and goes into the creeks near our tanks and go to fellow property owners. It will cause land erosion on my property. I challenge you all to look into the cons and not just the money. It will ruin our lives and our community way of lives. It will affect our health, my children, grandchildren and great grandchildren. Would you want an industrial scale solar farm by your home?

Gene Kleiber- I have right at a 200-acre farm within a mile of the lady that just spoke. The water that would come off her place from the solar farm would run right through the middle of my place. It's a water way that comes right through my place and dumps right into Cannon Snap Creek, as a farmer raised up on a farm, I know what the environment means to everybody, so I am opposed to this.

Natacha Kiler- Project Manager for the Thunderbird Solar, I am here on behalf of my company and for myself. Me personally I have been in this business since 2008. There are economic benefits, jobs, construction jobs, but also a few long term jobs that don't bring burdens to the communities. I really see so much good in Solar. I don't hear about toxic water run-off. You can look up anything on the internet and find anything on the internet. A lot of really good things about Solar, change is hard and scary.

Commissioner Shuffield- The toxic that they are worried about, if you had a hail storm and broke all the glass and ran into the water system, what would come out of those panels?

Natacha Kiler- Again, I haven't see that happen, I have seen hail storms come through, and have seen some breakage but not like oil spills.

Commissioner Shuffield- In a scenario if there was some breakage, is there anything inside that would contaminate the soil.

Natacha Kiler- I have never heard of such a thing, so my answer to that would be No. I don't know of any toxic chemical that would come from an event like that.

Commissioner Shuffield- Why Milam County?

Natacha Kiler- It's not just Milam County, because of the transmission capacity, nice flat land we look for. A lot of different things that go into a solar project, but transmission capacity it the main.

Commissioner Shuffield- You have flat rows, it looks to me like you would have run-offs and cause erosions

Natacha Kiler- we plant native grasses around the panels, native to the area. Civil Engineers that design it

William Coats- Milano project- I can say that there is no evidence of leeching or toxic chemicals, that is the whole point behind this. You can research and find an answer if you are looking for that answer. There is no evidence of that happening, very good opportunity for the county. We have a local contact that is part of our team, Chris Silverthorne who has knowledge of the area, we got to know about the Economic troubles with the smelters closing. That created transmission capacity. You need transmission capacity to build projects. Because of these closings you had over 1,000 megawatts in some of these substations. You also have economic distress because of those things closing. You got 4 or 5 companies out here wanting for a reason, its not like its going to happen and then 10 more companies come in. It's not like the whole county is going to be covered in solar panels. These companies do rely on tax abatements, its just the market. Projects in other counties are getting these abatements.

Sherry Brantley- What about Erosion? Does it happen? How are you going to stop that from happening?

William Coats- Watersheds are important to us, Mitigation for erosion is going to be important to any engineer whether it's a

parking lot, solar farm or a house. Enigineers will be involved. County Roads would be improved not dimished, Projects are not come and go. We are out here to be in business and neighbors for 30, 40, 50 years.

Commissioner Shuffield- What about safety? Fence with barbed wire, Is it safe, what if Matt's sons want to do a curiosity search and go in?

Natacha Kiler- Security is designed to keep people safe, it's a security fence and the solar panels are safe

Williams Coats- There is a current, your not touching the solar panel and getting electrocuted

Sherri Brantley- How many motors are used on the solar panel?

William Coats- It's a passive thing, the sun hits it, there is not motors

Judge Young- She is talking about turning the panels

William Coats - They do move towards the sun

Natacha Kiler- There are trackers, some do have some do not. Not sure how many

Sherri Brantley- How far from my fence will the solar panels be?

Natacha Kiler- 50 foot set back

Matt Goodson- State of Texas does not recognize if Solar is a mineral right or a surface right

William Coat- Surface Right

Matt Goodson- When does it makes its transmission from Ag to Surface?

Judge Young- Once improvements are in place the taxing begins. Then they go back and pay up front the past 3 years. We have looked at this and I am very much aware of your concerns. I am a Farmer and a Rancher, we have no say so, that is up to the landowner, he wants to lease it, he can lease it, once we get to this point, we have to make a decision on if we should give them a tax abatement. If the court finds that a designation will contribute to the retention or expansion of primary employment or will attract major investment in the zone and will contribute to the economic development of Milam County Court may approve.

Commissioner Hubnik- I have taken calls since Friday, last call was at 9:30p.m., all day Saturday and Sunday. I think we should table this until we can do more research and give people more time to be here. There was a professor in College Station that couldn't take off in time to get here, he was telling me about the negative impact would be, look at the Toxic chemicals in the construction of the panels. There are numerous people against this, can we table this and push back a week? I make a motion to table the item

Commissioner Muegge- Talking about the abatements, this is unique with solar, we have a board that does it, how it comes about. The companies are here and have spoke about it

Commissioner Shuffield- We went through the same thing for Humble and nobody came then, we have done been through this before.

Judge Young- I know there are some folks against, but if we table we aren't going to learn anything different

John Redington- Right now you are just creating the reinvestment zone, this just lets it be a possibility. Tax abatements let you have some kind of control.

Commissioner Shuffield- They can put the solar in without the abatement?

John Redington – Yes but with the abatement you have some kind of control and say so. You have agreements in place, takes out lawsuits, fighting that puts the county in a tight spot.
