The Milam County Commissioners Court will convene on Monday, July 25, 2022 beginning at 10:00 a.m. The Court will convene in person at the Milam County Courthouse in the Milam County Courtroom located at 102 S. Fannin Ave, Cameron, Texas. Court proceedings will also be broadcast by Facebook Live.

The following items will be addressed:

1. A quorum will be established and the Court will convene.
2. Invocation.
3. Pledge of Allegiance to the American Flag and to the Texas Flag.
4. Discuss the minutes of previous Commissioner's Court meetings and take any necessary action regarding approval, corrections and/or changes of the minutes of prior court action.
5. Public Participation:
  - a. The Milam County Commissioners Court will entertain any reasonable request from any citizen who wishes to address the Court, so long as the remarks are made pursuant to respectful decorum, the Texas Government Code and limited to five minutes or less.
6. Subdivision Platting Variance:
  - a. Discuss and take any necessary action regarding a requested platting variance for approximately 2.287 acres of land out of a 24 acre tract on County Road 342, appraisal district ID 22655.
7. Consideration and approval of an order by the Commissioners Court of Milam County, Texas authorizing the issuance of "Milam County, Texas tax notes, series 2022", levying an annual ad valorem tax, within the limitations prescribed by law, for the payment of the notes; authorizing the execution of any necessary engagement agreement with the county's financial advisor; and providing an effective date
8. Discuss and take appropriate action on the donation of a boat trailer from the Sheriff's Office to the Milam County Commissioners.

9. Discuss and take appropriate action on an updated interlocal agreement with Cameron ISD for additional school resource deputies.

10. Discuss and take any necessary action to pay the bills of Milam County, Texas.

11. Discuss and take any necessary action to adjourn the Milam County Commissioners Court.
