Public attendance may be limited due to COVID-19 spacing requirements and admittance may be done on a first come, first serve basis.

 - a. Discuss and take any necessary action regarding the purchase and staffing of a quick response vehicle in Milam County.
7. Discuss and take any necessary action to pay the bills of Milam County.
8. Discuss and take any necessary action to adjourn the Milam County Commissioners Court.
