Commissioner Muegge stated that this quarterly report is from January 1, 2022-March 30, 2022

Jennifer Ranspot presented a handout and went over handout, no action needed for anything today.

Financials:

We have extended hours, Monday-Thursday we work after 5pm so people have time to come in and see us after work.

Quality Assurance Monitoring:

Last Audit was back in August, We did a self-audit back in March for the Cameron and Rockdale Office everything was really good, I didn't find anything that stood out. Staff is doing a great job.

Food Delivery has to do with our WIC Cards, they are required to do an inventory quarterly and make sure all cards are accounted for.

Customer Service surveys are sent out by the State office, I can see all results. No negative or comments, only that we had was with the formula shortage.

Commissioner Shuffield- On the food delivery cards, do you see an increase of those because Bea's Kitchen shut down?

Jennifer Ranspot- We really don't because our cliental is different, mostly younger. With the cost of food going up we think that's why we have had an increase.

Participation/Caseload

Increasing very good, we are growing in numbers

Nutrition & Breastfeeding Conference June 21-23

Received a lot of information, we were closed, but we normally see people within the first 20 days of the month. We were available by cell phone; we can't load their cards by cell phone but we can take information.

There is a new app coming out for Texas WIC, they can schedule and reschedule their appointments, they can communicate with us.

Robert Kirkpatrick presented a handout and went over Our total services are down 50% with private pay, but if you count the COVID numbers we are up 500% or better with the vaccines we have provided. Our revenue with the TB screening has increased about 40% from what it first quarter 2019.

3. HEALTH DEPARTMENT QUARTERLY REPORT

a) CLINICAL SERVICES

Our total services are down 50% with private pay, but if you count the COVID numbers we are up 500% or better with the vaccines we have provided. Our revenue with the TB screening has increased about 40% from what it first quarter 2019.

b) IMMUNIZATION SERVICES

This is a slow quarter for us, most of the parents bring their kids to us before school starts or after school starts to be immunized.

c) INDIGENT HEALTH

Eligible clients is down about 10 from where it was in 2019. I am concerned about our Indigent Health Department because of Rockdale Clinic closing down or potentially closing.

d) PREPAREDNESS

Flu reports, we didn't have any this year, they were very low through the school.

e) SEPTIC

Our septic inspection reports are down from where they were, this is primarily for our aerobic systems. We are working with our service providers to try and encourage them to do the maintenance on them, but they are having trouble hiring people to do that work. Our renewals are right where we were in 2019. As of last week, we hit 90 and those are all new installations.

f) GRANTS

The Regional Local Health Services we've extended \$5,259.00 in that quarter.

The Community and Clinical Health Grant is to deal with obesity, I have had the job posted multiple times and I have not had luck in hiring anybody that was qualified.

I am also running out of space, when I applied for these grants, I was under the impression that we would be in our new facility and that is not the case and I do not have enough seats.
