

Jesse (CTCOG)- Judge Young plans were for road repairs; this funding was to go to anything related to flood litigation.

Suzanne Nelson (GLO) – Think about what’s happening in the areas where it floods and storms. Pick a risk, show how that project mitigates a risk.

The Engineer will help figure out how much projects are going to cost and how many projects you can do.

This funding helps the people who experienced hardships because of these events.

This money is to help protect people and property long term not temporary.

A building needed in the community that provides a place of shelter in a storm event or flood event.

When not being used as a storm shelter, using for community programs, providing a service to the people in the area that it is designated as the benefit area.

The State of Texas wants to use this funding to make the community more resilient so that the next time we get a severe flood, we will be better able to protect our property and our projects need to reflect that.

Stick to road and bridge and street improvements, flood and drainage projects.

New sewer lines, wastewater facilities.
