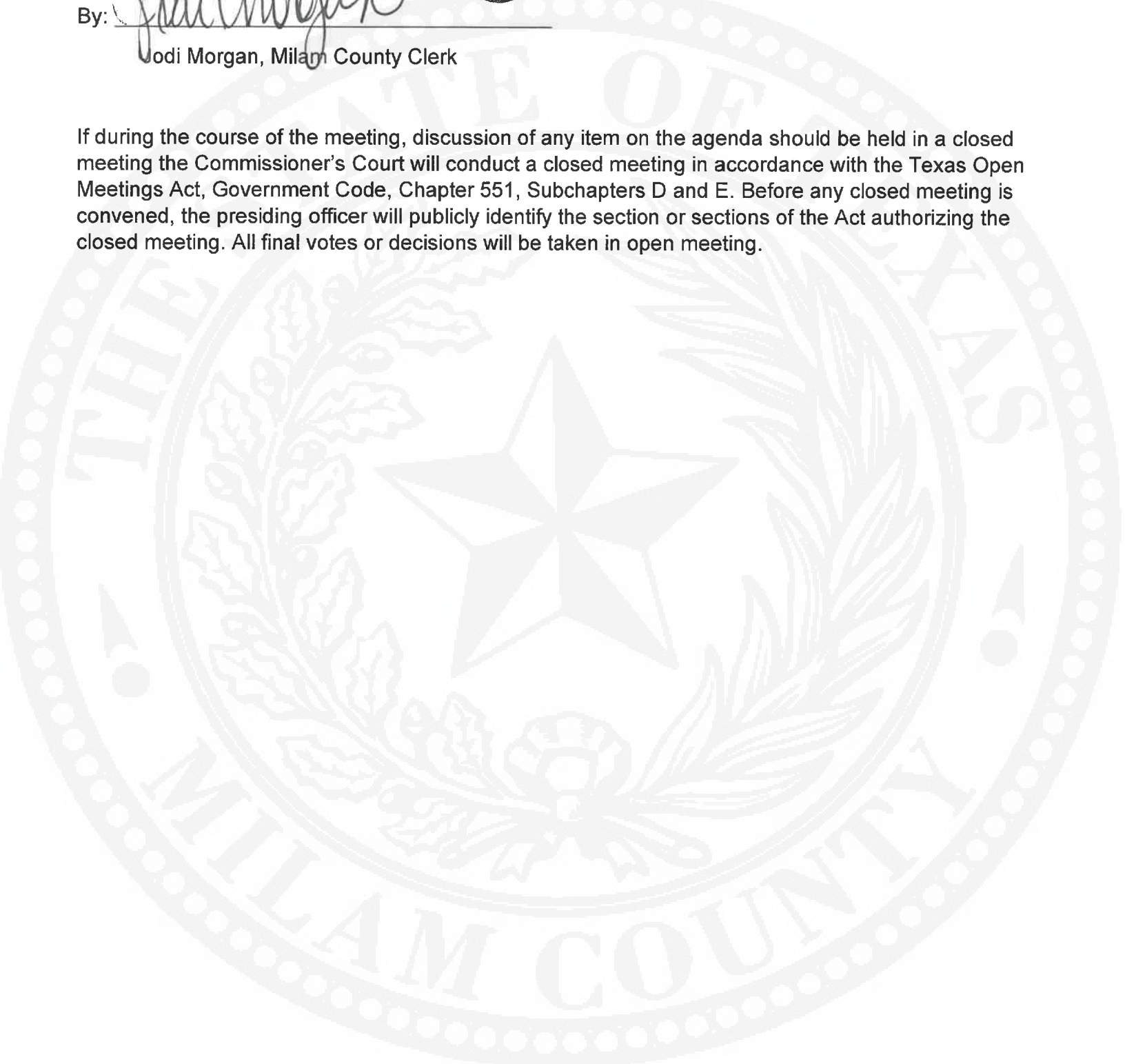

5. DISCUSS AND TAKE ANY NECESSARY ACTION REGARDING THE SELECTION OF ROAD AND/OR BRIDGE PROJECTS FOR A PENDING CDBG (BLOCK GRANT) FOR MILAM COUNTY

Motion by Commissioner Muegge to select County Road 203 Loop in PCT #1 and County Road 316A at the Yegua Creek in PCT #3 as priority projects and CR 442 at Salty Creek in PCT #4 and County Road 214 at Bear Creek in PCT #1 as alternate projects, Seconded by Commissioner Hubnik and approved unanimously.

PCT#1 Projects:

CR 203 Loop- bridge was replaced with culverts at one time, road is flooding and needs a bridge; estimate cost of \$70,130.76.

CR 214 at Bear Creek- replace culverts and put in a bridge; estimate cost \$65,239.16.

PCT #3 Projects:

CR 316A- Yegua Creek- pipe was put in is all rusted out, put bridge in.

CR 330- has a 30-inch culvert, need to replace with a larger culvert.

PCT #4 Projects

CR 445 – bridge has a wooden deck, boards are bad, want to replace with a concrete deck and widen it, Brushy Creek Slough \$29,950 just for materials

CR 442 at Salty Creek- Has a culvert there now, needs to be replaced with a bridge.
