

NOTICE OF FORECLOSURE SALE

Notice is hereby given of a public nonjudicial foreclosure sale.


4. Type of Sale. The sale is a nonjudicial deed of trust lien foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Monico Martinez and Norma Barrientos. The Deed of Trust is dated March 1, 2015, as recorded in the office of the County Clerk of Milam County, Texas, in Volume 1252, Page 779 of the Official Records of Milam County, Texas.

5. Obligations Secured. The Deed of Trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to (1) the Real Estate Lien Note in the original principal amount of \$33,000.00, executed by Monico Martinez and Norma Barrientos, and payable to the order of Hal D. Stanislaw and wife, Willyne Stanislaw; (2) all renewals and extensions of the note; and (3) any and all present and future indebtednesses of Monico Martinez and Norma Barrientos to Hal D. Stanislaw and wife, Willyne Stanislaw. Hal D. Stanislaw and wife, Willyne Stanislaw are the current owners and holders of the Obligations and are the beneficiaries under the Deed of Trust.

8. Default and Request to Act. Default has occurred under the deed of trust, and the beneficiaries have requested me, as Substitute Trustee, to conduct this sale. Notice is given that
