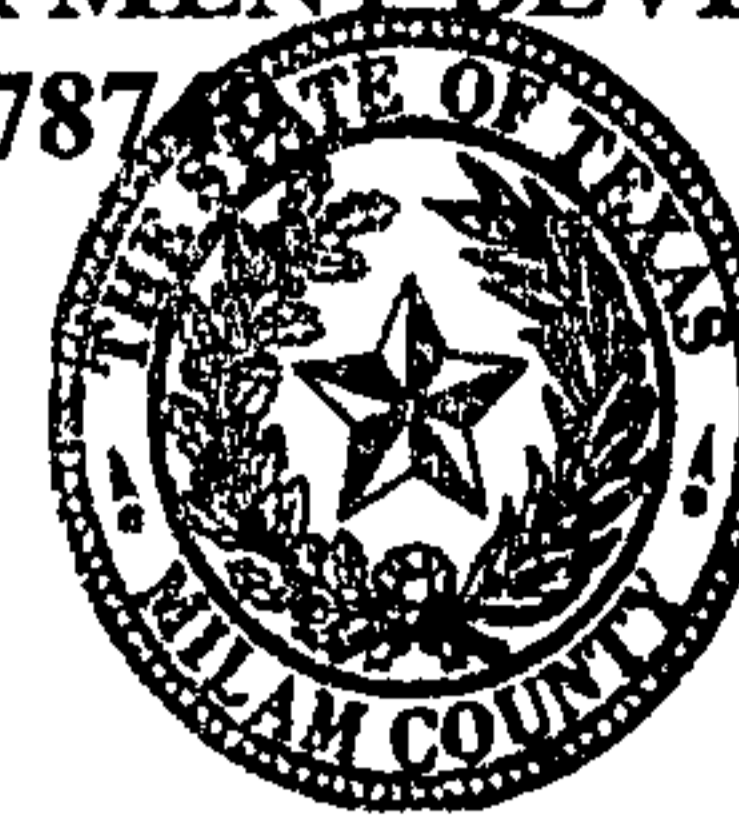

- (1) A copy of this citation,
- (2) A copy of the filed notice of intent to take depositions, and
- (3) A copy of the interrogatories that were filed with the notice of intent to take depositions.

The officer must return the original copy of this citation together with the required attachments to the Clerk of the Court stating in a written return thereon the time when and the place where such copy was posted.
