

ORDINANCE NO. 2023-01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MILANO, TEXAS, CANCELING THE GENERAL ELECTION SCHEDULED TO BE HELD MAY 6, 2023, FOR THE PURPOSE OF ELECTING ONE CITY MAYOR AND THREE CITY COUNCIL MEMBERS FOR A PLACE ON THE CITY COUNCIL; DECLARING AS ELECTED EACH UNOPPOSED CANDIDATE FOR THE OFFICE OF MAYOR AND CITY COUNCIL MEMBERS FOR THE CITY OF MILANO; FINDING THAT ALL NECESSARY AND REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; AND PROVIDING THAT THE MAY 6, 2023 GENERAL ELECTION SHALL NOT BE HELD; PROVIDING FOR POSTING OF THIS ORDINANCE ON ELECTION DAY, MAY 6, 2023; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; FINDING AND DETERMING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED WAS NOTICED AND IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND PROVIDING AN OPEN MEETINGS CLAUSE.

WHEREAS, the General City Election was called for May 6, 2023, for the purpose of electing one mayor and three (3) members to the City Council; and

WHEREAS, under these circumstances, Section 2.053, Texas Election Code, authorizes the City Council to declare the candidates elected to office and cancel the General Election;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MILANO, TEXAS, THAT:

Section 1. Findings of Fact. All of the above premises and recitations are found to be true and correct and are incorporated into the body of this Ordinance as findings of fact, as if copied herein in their entirety.

Section 2. Elected Candidates. The following candidates, who are unopposed in the May 6, 2023, General City Election, are declared elected to office, and shall be issued certificates of election following the time the election would have been canvassed:

Section 3. Cancellation of General Election. The May 6, 2023, General City Election is canceled.

Section 4. Directions to City Secretary. The City Secretary is hereby directed to post a copy of this Ordinance on the bulletin board at the City Hall and, on election day, a copy of this Ordinance shall be posted on the door of the polling place. The City Secretary shall issue a Certificate of Election in the same manner and at the same time as had the candidates been elected at an election, after such candidate qualifies for office in the same manner as if elected at the election.

Section 5. Severability. It is declared to be the intent of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this Ordinance is declared invalid by the judgment or decree of a court of competent jurisdiction, the invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance since the City Council would have enacted them without the invalid portion.

Section 6. Effective Date. This Ordinance shall take effect upon its final passage, and it is so ordained.

Section 7. Open Meetings. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and public notice of the time, place and purpose of said meeting was given, as required by the Open Meetings Act, Chapter 551, Texas Government Code.
