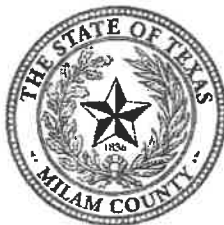

The following items will be addressed, discussed, considered, passed, or adopted to-wit:

23. Review, discuss and take action to pay the bills of Milam County, Texas as presented by the County Auditor's Office.




