## The following items will be addressed:

- 1. A quorum will be established and the Court will convene.
- 2. Invocation.
- 3. Pledge of Allegiance to the American Flag and to the Texas Flag.
- 4. Public Hearing Regarding Reauthorization of Guidelines and Criteria for Tax Abatements:
  - a. Discuss and take any necessary action to open and conduct a public hearing regarding the adoption, amendment, repeal or reauthorization of Guidelines and Criteria for Tax Abatement, giving members of the public a reasonable opportunity to be heard.
