The following items will be addressed:

1. Call Meeting to Order and establish a quorum.
2. Prayer.

4. Discuss the minutes of previous Commissioner's Court meetings and take any necessary action regarding approval, correction and/or changes of the minutes.
5. Hear public participation comments from the public who have timely made a proper request and take any necessary action regarding such request and/or comments.
6. Discuss and take any necessary action on the COVID-19 Pandemic in Milam County, including:
 - a. Update on the pandemic; and
 - b. COVID-19 case summary.
7. Update on the annex and Professional Building renovation:
 - a. Update on publication of the notice of exchange;
 - b. Appraisal of the involved property;
 - c. Professional Building renovation; and
 - d. Grant update.
8. Milam County Historical Commission presentation:
 - a. Discuss and take any necessary action to present the distinguished service award to the Milam County Historical Commission.

9. Discuss and take any necessary action to approve a proposed resolution regarding a new bridge for County Road 216 at Big Elm Creek in Precinct 1, under the direction of Commissioner Watkins. Specifically, a request of waiver regarding a TxDOT grant for the cost of construction including a waiver of a 10% match by Milam County.
10. Discuss and take any necessary action to approve a resolution approving the County Transportation Infrastructure Fund Grant Program agreement with TxDOT in the amount of \$538,457.00 for road repairs in Milam County.
11. Discuss and take any necessary action to approve a resolution approving a grant in the amount of \$1,570.00 to Hill Country Community Action Association, Inc. for home delivered meals in Milam County.
12. General Land Office Mitigation Grant:
 - a. Discuss and take any necessary action to issue requests for proposals for administrative services and request for qualifications for engineering services related to the Community Development block grant-Mitigation grant programs administered by the Texas General Land Office.

15. Utility Installations:
 - a. Discuss and take any necessary action regarding a request from Southwest Milam for new water line on County Road 322 at the intersection of County Road 322 and County Road 334 and extending approximately .7 miles west of the intersection of CR 334 and County Road 322 for new water service.
 - b. Discuss and take any necessary action regarding a request from Southwest Milam for new water line on County Road 322 at the intersection of County Road 322 and County Road 334. Specifically Southwest Milam proposes a bore location on CR 322 at the intersection of CR 322 and County Road 334 on the West side of County Road 334. Bore is for new water service, using 12" PVC casing for an 8" pipe extending across entire row, with a minimum 36" depth.
 - c. Discuss and take any necessary action regarding a request from Bartlett Electric to cross County Road 429 at a location ¼ miles south of FM 908 for the El Camino Real Estates.
 - d. Discuss and take any necessary action to allow Bartlett Electric to install an electrical pole and cross County Road 418 with an aerial line .13 miles south of FM 487.

16. Discuss and take any necessary action to pay the bills of Milam County.
