**This week we are getting more mask from Bitmain that will go to 1<sup>st</sup> Responders**

**We did get some more mask, but they were so old that the straps had deteriorated off, Bill Harris of Cameron Tire has said he will fix those for us Bea's Kitchen will start Thursday handing out frozen meals; Senior Citizens will have to sign up for it. Rockdale is also doing the same thing.**

**I will draft an order to present to court on Monday for the Employees that are missing work to be paid.**
