

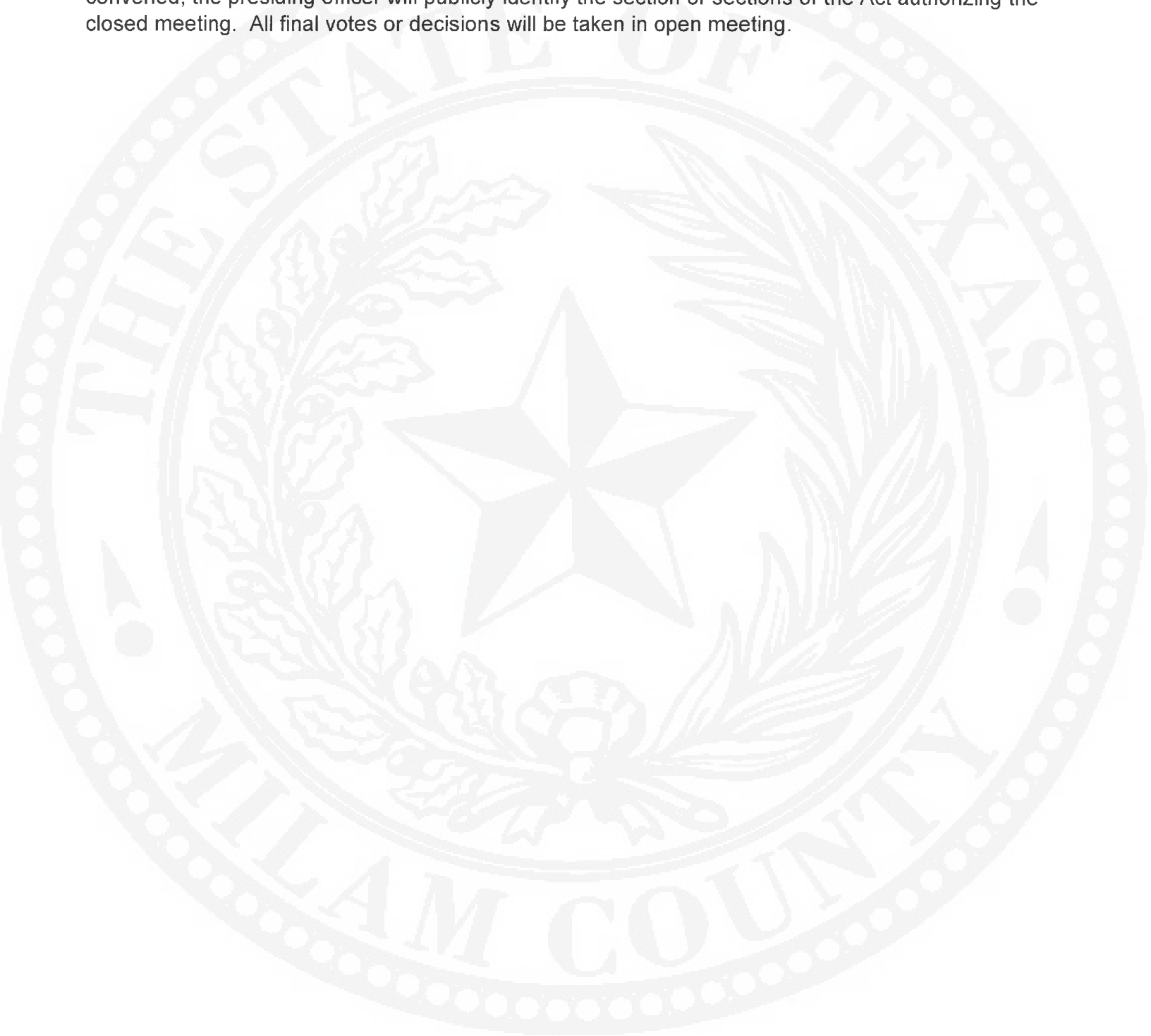

Slogan will be “Milam County a Cleaner Place to Live”. Dyann White with the Appraisal District is going to go back out and re-evaluate the property, we can then look at selling the property through an auction with a minimum starting bid.**
