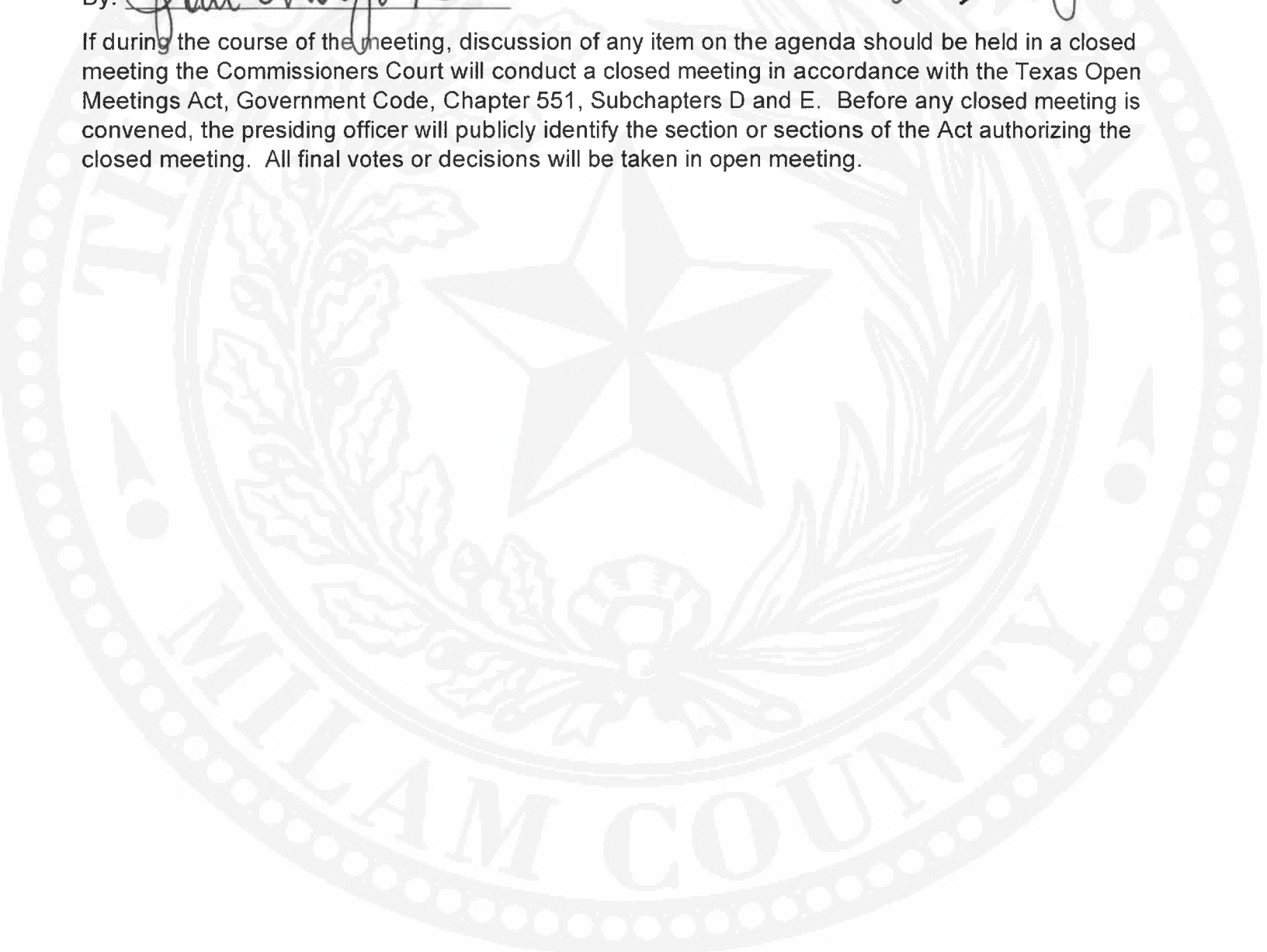

- Disaster Order expired at 12:01am this morning; Governor's order supersedes our order and is still in effect

Judge Young reported that had received several calls over the holiday weekend from County residents who needed COVID testing but could not get it. He explained that testing is not available in the County on the weekends from any of our medical providers and thus anyone who needs testing must go out of the County. Further, the tests that are given take a long time for results. In several instances, those with symptoms were tested, but continued with their normal activities while awaiting results, which in some cases take as many as ten days. This conduct simply helps spread the virus. As of today, Milam County had 112 confirmed cases, 21 active cases, 50 individuals being monitored, 2 hospitalized and 1 fatality.

Robert Kirkpatrick- We have not gotten the results back from the test that were done last week. 400 people were tested last week in Milam County, on June 29, 30 and July 1, 2020, but a week later, no results. We worry that these people continue to spread the virus while we wait for the test results.

Today Texas has 195,239 confirmed cases with 2,637 deaths. Hospitals in Bexar and Harris County getting full. Austin Mayor speaks of stay home order and no hospital rooms in about ten days.

Bryan Burns- We have given out 37,000 mask and other PPE items, I am going to pick up more supplies tomorrow. We can do another walk up testing site, we just need to decide on a date and location. Best advice is to wear a mask and stay 6 feet apart from others.
