NOTICE FOR ADOPTION OF DESIRED FUTURE CONDITIONS FOR GROUNDWATER MANAGEMENT AREA 12 AND GROUNDWATER MANAGEMENT AREA 8

The Post Oak Savannah Groundwater Conservation District (District) will hold a **Public Board Meeting** at **5:30 pm, October 11, 2022**, at the District's office at 310 E Ave. C, Milano, Texas, for the purpose of discussing and adopting Desired Future Conditions for the relevant aquifers in Milam and Burleson Counties, which were adopted by Groundwater Management Area 12 (GMA 12) and Groundwater Management Area 8 (GMA 8) in resolutions and explanatory reports and deemed admiratively complete by the Texas Water Development Board pursuant to §36.108, Texas Water Code.

GMA 12 includes the groundwater conservation districts as follows: Brazos Valley Groundwater Conservation District, Fayette County Groundwater Conservation District, Lost Pines Groundwater Conservation District, Mid-East Texas Groundwater Conservation District, and Post Oak Savannah Groundwater Conservation District.

GMA 8 includes the groundwater conservation districts as follows: Central Texas Groundwater Conservation District, Clearwater Underground Water Conservation District, Middle Trinity Groundwater Conservation District, North Texas Groundwater Conservation District, Northern Trinity Groundwater Conservation District, Post Oak Savannah Groundwater Conservation District, Prairielands Groundwater Conservation District, Red River Groundwater Conservation District, Saratoga Underground Water Conservation District, Southern Trinity Groundwater Conservation District, and Upper Trinity Groundwater Conservation District.
