### SANDOW MUNICIPAL UTILITY DISTRICT NO. 1

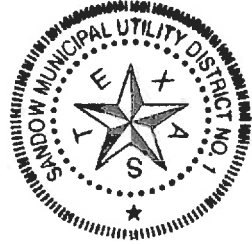

  - j. FM 1786 Intersection Improvements; and
  - k. AMLC Master Drainage Study.
